Disability Living Allowance (DLA) is a tax-free benefit for disabled children and adults to help with extra costs you may have because you're disabled. Find out more about Disability Living Allowance, including how much you can get.

Who can get Disability Living Allowance?

You may get Disability Living Allowance if:

- you have a physical or mental disability, or both
- your disability is severe enough for you to need help caring for yourself or you have walking difficulties, or both
- you are under 65 when you claim

Already claiming DLA and want to report a change in your circumstances - find out more

You can get Disability Living Allowance whether or not you work.

It isn't usually affected by any savings or income you may have.

If you're aged 65 or over, you may be able to get Attendance Allowance.

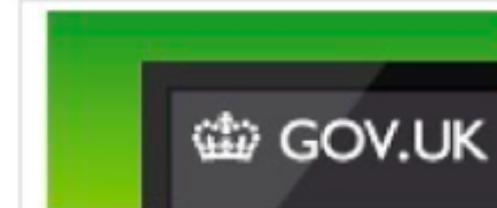

Headlines from the report for the Department for Work and Pensions include:
Focusing the second phase of the Innovation Fund on vulnerable young people – including gang members.
Further support for ex-offenders by referring prison leavers directly to the Work Programme. This is expected to start in March 2012.
Iain Duncan Smith, Secretary of State for Work and Pensions said:
"Gangs are having a devastating impact on our most deprived neighbourhoods. The violence they perpetrate leaves communities living in daily fear, feeling powerless to do anything.
"Tackling this is a key Government priority. Local communities, including their young people, should be supported to deliver a clear message that enough is enough, and local agencies, police and the voluntary sector can together provide the services needed to stop the violence. Those gang members who want to exit gang life should be helped to do so, but those who continue to commit violence should feel the full force of the law.
"Only by effectively working together can we turn the tide of gang violence, and in doing so transform the lives of the young people and families in these communities."

Successful bids for a share of £1.2m funding to support young people suffering sexual violence, including by gangs, have been announced today.

Eight organisations with a track record of working with young people, victims of sexual violence and street gangs across the country have been funded to recruit 13 new young people advocates. Each post will be awarded a grant of £30k per year for three years.

Young people's advocates

Working in many of the areas most affected by gangs, the young people's advocates will provide direct and dedicated support to young people who have been victims of sexual violence or exploitation, or who are at risk of becoming victims. The advocates will provide a vital link between existing services to ensure victim's needs are met.

Equalities Minister Lynne Featherstone said: 'For too long the shocking level of abuse of girls and young women associated with gangs has been kept hidden. That is why we continue to take action to raise awareness, provide skilled and sensitive support to victims and work hard to prevent it happening in the first place.'

A conference held by the YJB in 2003 highlighted growing concerns in Britain about the reported increase of gang-related offending and the use of weapons by young people, and a lack of hard evidence on both of these issues and still less evidence about whether the two were related. The YJB commissioned research to try to fill these gaps and to discover the factors underlying any trends, as well as identifying their implications for policy and practice.

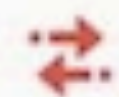

1. How it works

You could get £62.70 a week if you care for someone at least 35 hours a week and they get [certain benefits](#).

You don't have to be related to, or live with, the person you care for.

You won't be paid extra if you care for more than one person.

Carer's Allowance can affect the [other benefits that you and the person you care for get](#). You have to pay tax on it if your income is over the [Personal Allowance](#).

3. Make a lasting power of attorney

You can make a lasting power of attorney (LPA) online or using paper forms.

Either way, you need to get other people to sign the forms, including the attorneys and witnesses.

You can get someone else to use the online service or fill in the paper forms for you, for example a family member, friend or solicitor.

You must [register your LPA](#) or your attorney won't be able to make decisions for you.

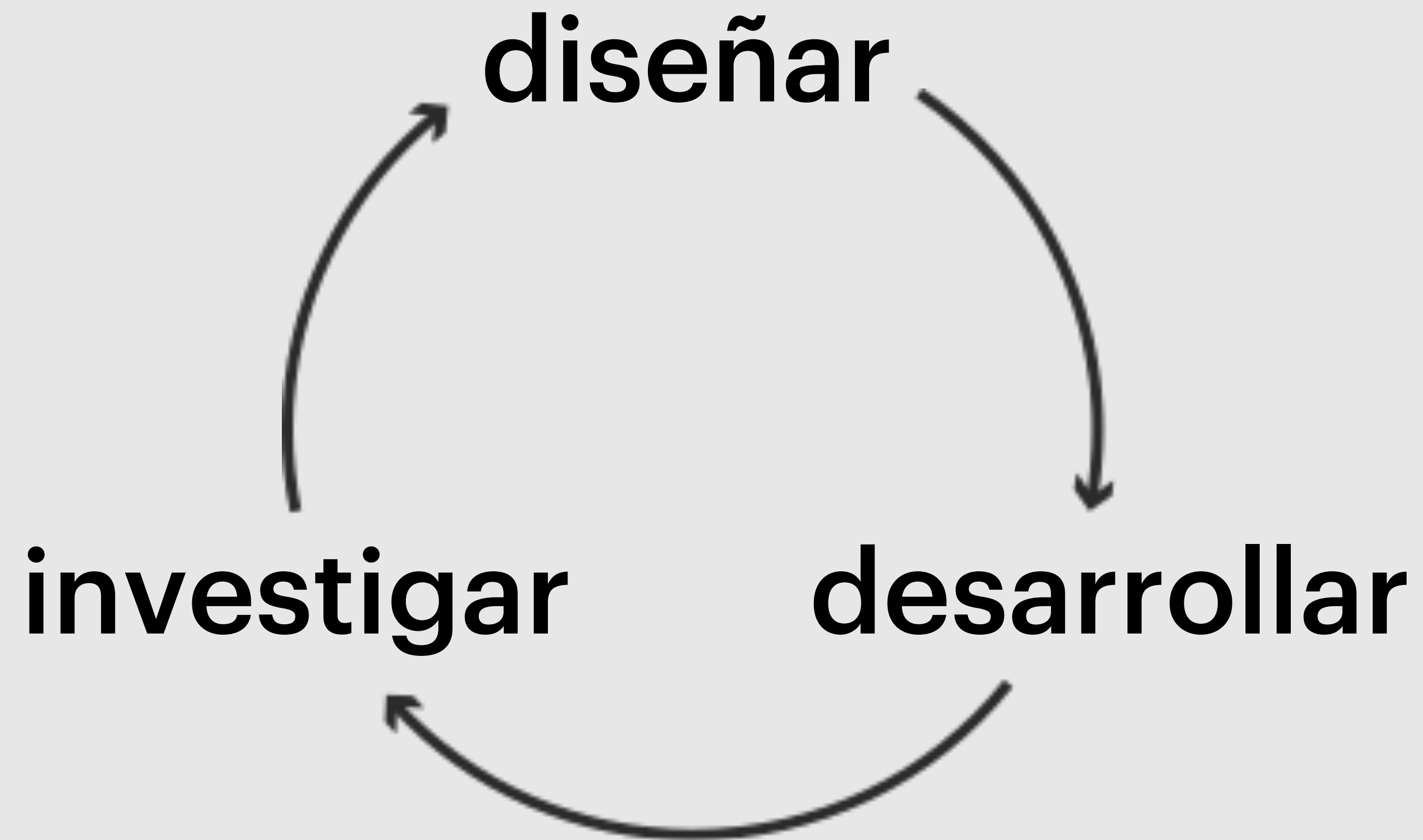
